## **COVENANTS AND SAFETY REMINDERS**

Reports of violations may be sent to <u>safety@lasonata.org</u>. Please include pictures with time stamp and location, and, for overnight street parking: color, make, model, license plate state, and number.

Lawns and shrubbery (CCR 4.4) shall be kept mowed and trimmed, with grass in excess of eight inches being in violation of these mowing requirements. Landscaped beds should be free of weeds with shrubbery pruned as needed. Yards consistently unmaintained can end up costing homeowner \$100 fine.

**Overnight street parking** in LaSonata is not allowed (CCR 4.6). Overnight street parking is considered to be between 1

am and 6 am. Overnight parking in the street can end up costing homeowner a **\$100** fine.

Trash containers (Rules IV. D.7/Municipal Code Ch 49, Sec 45) must be placed behind the front house building line. Trash and trash bins may not be put out for pick up before 7:00 pm the evening before pick up and must be returned to their storage location by 8:00 pm the evening of pick up. Placing trash out for pick up for a longer period is subject to a fine by the City of Oklahoma City and the La Sonata Homeowners Association.

#### BOARD OF DIRECTORS/GENERAL MEMBERSHIP MEETINGS

Proposed change to Bylaws to be voted on by the Board of Directors at the October 8, 2019 meeting affecting Section 4: Quorum Diminishing Quorum at Meetings: If a quorum of voting members is not met by the start of the meeting, that meeting will be adjourned. At that time a second meeting will immediately be called to order and the number of dues-paying members present (including legal proxies) will constitute a sufficient quorum and business will then be transacted and completed.
